Refund Rules:

The Schedule of refund of fees will be as follows as per UGC rule December 2016:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following four-tier system for the refund of fees remitted by the student.

Refund Rules on cancellation of admission:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following four-tier system for the refund of fees remitted by the student.

| Sr. No. | Percentage of Refund of Aggregate fees* | Point of time when notice of withdrawal of admission is served to the Institute |
|----------------|--|--|
| 1 | 100% | 15 days before the formally-notified last date of admission (on or before 4th July 2018) |
| 2 | 80% | Not more than 15 days after the formally-notified last date of admission (5th July to 4th August 2018) |
| 3 | 50% | More than 15 days but less than 30 days after formally-notified last date of admission (5th August to 19th August 2018) |
| 4 | 00% | More than 30 days after formally-notified last date of admission (20th August 2018 onwards) |

In case of (1) in the table above, the deduction will be 10% of the aggregate fees as processing charges from the refundable amount. Aggregate fees is inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).
